Mr. Gilles Gutierrez – Council Member CEO **ICP Concepts Ltd**

Born in 1949 in Abidjan (Ivory Coast), married with three children. Doctoral thesis in Pharmacy at the University of Lyon, France.

In 1982, Gilles Gutierrez founded the TEXINFINE Laboratory in France, specializing in the development of pharmaceutical forms. He is also the creator of the Institute for Cellular Pharmacology in Malta (1998), a research centre for new pharmacology substances to be used in human and animal health domains.

In 2004, he discovered a new molecule, Maltanedienol, a chemical substance extracted from brown algae, Padine, to be found in abundance in the Mediterranean sea. Thanks to the personal intervention of the President of the Republic of Malta, Mr. Guido De Marco, the skeleton of this molecule was named Maltanedienol to refer to Malta. Professor Marc Brincat, Dean of the Malta Medical School, was in charge of its clinical development and emphasized the importance of this substance in the treatment of bone age degeneration. Scientists from Malta and Tunisia, associated with this discovery, are continuing their work to promote this molecule that has its origin in "Mare Nostrum".

A number of patents, publications and communications are landmarks along Gilles Gutierrez's career path. His principle focus in biological research is the evolution of degeneration due to ageing.

The role of the French Foreign Trade Advisors

Since 2008, Malta has its French Foreign Trade Advisors, who are Mr. Edouard de Lamarzelle and Mr. Gilles Gutierrez. Both are also members of the MFCC (Maltese French Chamber of Commerce).

What is the role of a Foreign Trade Advisor?

Chosen for their competences and their international experience, the "France Foreign trade advisors" (CCEF / Conseillers du Commerce Extérieur Français) are named for three years by decree of the French Prime Minister on a proposal from the Minister of Foreign trade. For 114 years, their selected members have been providing their expertise and sharing their experience on a voluntary basis in favor of French economic activities all over the world in the following ways:

- · by advising the public authorities;
- · by sharing their expertise to companies, in particular SME's, which they help promote in their international development;
- · by encountering the younger generation and raising awareness on the importance of international trade in their careers (...), via the promotion of the "V.I.E" Volunteers of International Enterprises (Volontaires Internationaux en Entreprise).



The main mission of a Foreign Trade Advisor is to observe foreign trade issues. From their observations of the international markets and utilizing their expertise in their field, they convey their findings, opinions and recommendations to the public authorities which help them in the decisions making process. Through a partnership with the state institutions directly involved on French foreign trade topics (Embassy of France, Ubifrance, Chambers of commerce, Medef International, Coface, Oséo, AFII, etc...), the CCEF organizes in France and all over the world, conferences, seminars and regional symposiums. These meetings allow the CCEF and the economic decision makers (both French and international) to analyse and share their findings on the issues and opportunities of world trade and/or on specific markets.

The presence of the CCEF is relevant in more than 146 countries worldwide. Commissions exist to address specificities relating to a geographical zone, but also relating to a sectorial activity or even a specific topic requiring expertise. This grid and mixing of expert testimony allow the French or Maltese companies wishing to develop their business, the ability to benefit and profit from a network of expert quality testimony.

Qu'est ce qu'un Conseiller du Commerce Extérieur?

Choisis pour leur compétence et leur expérience à l'international, les « Conseillers du Commerce extérieur de la France » (CCEF) sont nommés pour trois ans par décret du Premier ministre sur proposition du ministre chargé du Commerce Extérieur. Depuis 114 ans, ils mettent bénévolement leur expérience au service de la présence économique française dans le monde :

- · en conseillant les pouvoirs publics ;
- · en transmettant leur expertise aux entreprises, notamment les PME, qu'ils parrainent dans leur développement à l'international;
- · en allant à la rencontre des jeunes qu'ils sensibilisent aux métiers de l'international et en assurant la promotion du programme des Volontaires Internationaux en Entreprise

La principale mission d'un Conseiller du Commerce Extérieur est de mener une action de veille sur les questions du commerce extérieur. Au cœur des marchés internationaux et experts dans leur domaine, ils transmettent leurs informations, avis et recommandations aux pouvoirs publics dont ils éclairent les décisions. En partenariat avec les principaux acteurs institutionnels du commerce extérieur français (Ambassade de France, Ubifrance, Chambres de commerce, Medef International, Coface, Oséo, AFII, etc...), les CCEF organisent, en France et dans le monde, des colloques, séminaires et symposiums régionaux. Ces rencontres permettent aux CCEF et aux décideurs économiques (français et internationaux) de confronter et transmettre leurs



expériences ou analyses sur les problématiques des échanges mondiaux ou des marchés spécifiques.

La présence des CCEF est assurée dans plus de 146 pays dans le monde. Des commissions existent par zone géographique, mais également par activité sectorielle ou spécialité.
