On the local front, I am also delighted with our recent announcement of another 3-year sponsorship agreement with Bank of Valletta who is now the Chamber's Official Partner alongside our two sponsoring partners, RCI Life and Wins Ltd.

Once again, I take this opportunity to thank all the council members, the French Embassy and all those who in some way or another are collaborating with the Chamber.

A Brief Message by H.E. Ms Béatrice le Fraper du Hellen, French Ambassador to Malta.



It is a pleasure for me to be given this opportunity to address you all, members of the Malta French Chamber of Commerce, directly through this very informative quarterly newsletter.

Let me share with you some thoughts that I expressed on the occasion of Bastille Day at the French Residence.

This has been an exciting year in Malta with the Presidency of the Council of the European Union. These six busy months have created an appetite for more, not less international events. And it is with much anticipation that we are looking forward to the Our Ocean Conference that will take place in Malta in October 2017 and of course to Valletta 2018 European capital of culture.

Looking forward, France itself will organize a series of events in the months and years to come. French President Macron has announced a new climate conference next 12 December to take stock of and reinforce the implementation of the Paris agreement on climate change.

France is also a highly motivated candidate to host the Olympic and Paralympic Games in the summer of 2024, one hundred years after Paris hosted the first Olympic Games of the modern era in 1924. In a way which is very reminiscent of the Maltese citizen mobilization for the EU presidency, French citizens are wholeheartedly supporting this project.

As I have already had the opportunity to state in other occasions, I feel the relationship between Malta and France has been growing from strength to strength.

There are about 2000 French citizens in Malta working in highly dynamic sectors such as financial services, tourism, the maritime sector and digital economy. French companies present in Malta such as TOTAL Pamargan in Gozo, STMicroelectronics the French-Italian venture, Freeport operator CMA CGM and many subsidiaries of French brands in Malta employ more than 3 000 Maltese citizens, including CEOs.

We were glad to host this year in Paris two delegations from the Malta Communication Authority, which met with our entities involved in digital economy and incubators of start-ups, and from MIMCOL and MGI, whose CEOs met their French counterparts as well as several representatives from French companies.

We again have benefited all year long from the support of the Maltese-French Chamber of commerce under the guidance of Joe Bugeja and I was privileged that the continuing partnership between the Chamber and BOV was confirmed in a ceremony at the French Embassy.

As we enter into new collaborations that will reap new advantages and opportunities to both French and Maltese entrepreneurs, I reiterate my Embassy's support and look forward to achieving new successes together for the benefit of both our economies.


New Business Talks between Malta and French Polynesia

Reading Investor Sentiment

There was an immediate need for a proper sentiment index about investments on the market.

This gap has recently been narrowed with the BOV Asset Management Investor Sentiment Index. Launched last month, this Index is the result of a survey conducted among 300 local investors by MISCO International Limited.

The first reading showed that Maltese investors have a preference for local investment, with a predominantly conservative risk appetite. Also, almost half of the respondents claimed to capitalise on government stocks. On a positive note, over the past five years, younger investors joined the market. Most investors in Malta use an intermediary, namely a financial institution or consultant, with only 10% having the confidence to invest without seeking advice.

As Mark Agius, Executive Head BOV Asset Management explained, "This index is a very important tool, not only for the investors, but for all stakeholders, including stockbrokers and insurance companies." BOV Asset Management Limited is committed to conduct this research on a semi-annual basis, thereby enabling all key players to keep abreast investor sentiment, and take necessary action.

In an effort to explore and promote the natural resources of Malta, ICP Ltd. Malta and ICP-TEXINFINE, France have launched a new research project in collaboration with BirdLife Malta to investigate the natural potential of the Salini Salt Pans.

Previously reported in the Times of Malta (https://www.timesofmalta.com/articles/view/201 60711/local/minister-gets-biological-to-explain-salini-waters-red-hue.618526), the planned

project, led by Dr Gilles Gutierrez, is set to further investigate the distinctive, naturally occurring microalgae of the Salini Salt Pans. High magnification microscopes and UV spectrometers as phylogenetical and physical assessments will be used to determine the microalgae involved in the colourful appearance of one of Malta's most distinctive heritage sites.
